

Selected Reflections from the 2024 Week Without Driving

From September 30-October 6, 2024, many residents of Humboldt County, California participated in the second National Week Without Driving. In doing so, they challenged themselves to live their lives without driving a car, in order to gain a better understanding of the experiences of people who can't drive for reasons such as disability, age or income. Many participants shared reflections on their experiences with CRTP or in posts on social media.

"I am noticing that there is a lot less doing things spur of the moment on the way home from work. I also can't turn around if I forgot something or need to go back for any reason. Once you're on the bus... you're going!"

"We've noticed many of the benches and overhangs for bus stops have been removed in Eureka, leaving no place for seniors, disabled folks or children to rest. No overhang leaves community members exposed to wind, rain. This may contribute to less people being willing to ride the bus in general."
